WHEREAS, the Board of Education of the Dubuque Community School District (the "District") anticipates a proposal to sell real property located along the Southwest side of the Audubon Elementary School grounds, 605 Lincoln Ave., Dubuque, Iowa, generally described as the southwesterly 15 feet of Lots 2 and 3 of Mineral Lot 314 and additional area within the southeasterly 12 feet of the southwesterly 20 feet of Lot 2 of ML 314, to be platted substantially as described above by plat of survey to be recorded prior to conveyance and consisting of approximately 4,453 square feet in area; and WHEREAS, it is appropriate pursuant to Iowa Code Section 297.22 to set a hearing on the proposed conveyance, and to publish a Notice of the proposed conveyance and of the hearing, and to receive and consider public comment for and against the proposed conveyance; NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Dubuque Community School District: Section 1.
